



Official Regulations – Fun Race

Infront Italy S.p.A. as a temporary grouping of companies together with Corriere dello Sport S.r.l., Atielle Roma S.r.l. and Italia Marathon Club, a limited liability amateur sports club, affiliated to the Italian Athletics Federation (FIDAL) with code RM094 (hereinafter jointly referred to as the "Organisers"), organise the non-competitive race, officially named "**Fun Race**", to be run over a recommended distance of 5 Km, voluntarily and autonomously.

Fun Race will be in **physical version** on **Sunday 27 March 2022**, with a departure time at 9.15 from via dei Fori Imperiali. It will finish in Circo Massimo.

The race will have a **virtual version** on **Saturday 26 and Sunday 27 March 2022** (48h of time to cover the distance), **in an autonomous, widespread and independent form, with respect to any location and choice of time.**

Rules of participation

The Fun Race is the non-competitive city race in conjunction with Run Rome The Marathon. The distance to run is about 5km. Participation is allowed for any age, but children under 14 must be always accompanied by a parent or a legal tutor. In order to participate, it is necessary to read and fully accept these rules.

Covid-19 Security measures

The organizer will be in compliance with the regulations in force in Italy for the containment measures for Covid 19. In the weeks before the event it will be published on the official media channels and will be send directly to all the participants the necessary documentation to respect in the event.

Entry fees

The bibs of the "Fun Race" can be purchased through the official website of the event www.runromethemarathon.com at the following rates:

Individual **Children (0-8 years old)**

- € 3,00 – only bib and medal *

Individual **Adults (over 8 years old)**

- € 13,00 – bib + race pack + medal (if applicable *)

Groups of **at least 4 people (over 8 years old)**

- € 10,00 – from the fourth participants - bib + race pack + medal (if applicable *)

Early price **Adults (over 8 years old)**

- € 9,99 – until 6th January 2022 - bib + race pack + medal (if applicable *)

The participant will receive an e-mail communication valid as an official "**confirmation letter**". This e-mail will contain all the basic instructions for collecting the bib and participating in the Fun Race. It will not be necessary to print a hard copy of the email, it will be possible to present it on an electronic device such as a smartphone or tablet.

The registration fee includes:

- Bib number;
- Gym bag with any products offered by sponsors;
- Official T-shirt in technical fabric;
- * Participation medal (only for children under 18 years old);

In case of event cancellation due to the continuation of the Covid-19 pandemic, registrations will be moved free of charge to the next edition.

How to register

Registration must be done online, following the instructions on the website www.runromethemarathon.com. If the participant has purchased a code from a third party, it is to be used on the site to finalize the registration.

2020 Registration conversion

All athletes registered from the 2020 edition, which could not take place due to the health emergency, will be able to **convert their registration to the 2022 edition** in the following ways:

- **Free of charge** by 03/02/2022;
- At the cost of € 5,00 per person from 04/02/2020 to 25/03/2022*,

** Cost related to event management expenses*

All individuals registered for the 2020 edition will receive a communication via e-mail with instructions to confirm their registration in 2022 edition.

Closing of registration

The finalization/registration must in any case take place on the site of the event, in the appropriate section **by 25/03/2022**.

For virtual version, we guarantee the delivery of materials before the race date if the registrations will be done until 19/03/2022, otherwise material will be delivery after the event data.

Entries received after this deadline will not be accepted. The organisation reserves the right to close registrations in advance or to accept registrations after the closing date at its sole discretion.

In any case, it will be possible register at the Expo Village. The organizer could close the registration at 8.000 participants for the physical version.

Bib numbers and event packs pick-up

The bib number and the race pack (gym bag with any products offered by sponsors and the official T-shirt) can be collected at the Expo Village on **Friday 25 and Saturday 26 March 2022 (from 9 am to 8 pm)** upon presentation of a valid identity document and confirmation letter.

It will also be possible to choose the **home delivery** option at a cost of:

- **To Italy:** € 5.00 per race pack or € 2.50 per race packs (minimum 2 people);
- **To EU countries:** € 15,00;
- **To Non-EU countries:** € 35,00.

For those who choose the home delivery, the bib number and the race pack will be delivery from 8 March 2022. The delivery will take place by express courier within 24/72 working hours from the data of shipment. It will be send also a tracking number.

It will not be possible to collect the bib number and the event pack on Sunday 27 March 2022.

Security procedures

Further information and more details will be provided to athletes in the weeks preceding the race with reference to the recommended sites to perform the activity.

Missed performance

If the race is cancelled, postponed to another date and/or, in any case, not held due to causes not dependent and/or not attributable to the will of the Organisers, including the revocation of the authorisation to run by the competent Public Bodies, for any reason whatsoever, the participant will not be able to make a claim against Infront Italy S.p.A. or other co-organisers, not even as a reimbursement of expenses incurred and sustained. The signing of the application form is also valid as a waiver of any claim for damages and/or compensation, and/or any claim for compensation and/or the reimbursement of any financial loss suffered and being suffered.

Statement of liability

By registering for the "Fun Race", the participant declares that they are fully aware and unconditionally accept these rules and regulations and they are aware that participating in the "Fun Race" and/or sporting events in general is potentially a risk activity. The participant also declares that they assume all risks arising from their participation in the event: falls, contact with vehicles, other participants, spectators or others, weather conditions, traffic and road conditions, or any type of well-known and assessed risk. By submitting the online registration form, the participant absolves and indemnifies the Organisers, the promoters, the City Administration of Rome, the Regional Administration of Lazio, all Sponsors of the event, their respective representatives, successors, officers, directors, members, agents and employees of the above-mentioned companies, from all present and future claims or liability of any kind, as well as for damages to persons and/or property, known or unknown, resulting from their participation in the event.

Furthermore, by submitting the online registration form, the participant declares that they are not aware of any previous medical condition or injuries that could put themselves at risk during the event.

Privacy and Image Rights

In relation to the processing of personal data, the competitor, by selecting the appropriate box at the bottom of the online registration form, declares to have read the information pursuant to Art. 13 of EU Regulation 679/2016 ("GDPR") ("Privacy Policy") made available through links and to have been informed through the aforementioned Privacy Policy that the consent for the processing of data strictly necessary to participate in the race is not necessary, insofar as the different legal bases of the processing indicated operate. The provision of personal data by the competitor is optional, however, refusal to provide data will make it impossible to proceed with the registration for the activity in question. For purposes not strictly related to participation in the race, the processing will only take place with prior consent, which, in any case, may be revoked by the competitor at any time.

The data must be complete, up-to-date and readable for insurance purposes.

The data, as better indicated in the Privacy Policy, which is an integral part of these Regulations and which is herein intended to be referred to in full, may also be disclosed and processed by third parties who offer services connected and related to the competition, such as, by way of example: services with the purpose of timekeeping, drawing up and announcing the results lists and services for the purpose of photographing or filming the competitor. These entities, with regard to the processing carried out on behalf of the data controllers (as defined in the Privacy Policy) in relation to activities outsourced by them, will act as "external data processors" pursuant to Article 28 of the GDPR. Some, however, may act as "data controllers" of the data transmitted, subject to the issue of appropriate information pursuant to Art. 14 of the GDPR, unless otherwise provided by law.

The competition will be the subject of audio-visual filming and consequently images, photos, videos, audio - and/or video recordings of any kind in which the competitor may appear, as well as the results and rankings, may be the subject of disclosure, publication and/or dissemination in any form. Athletes expressly authorise the Organisers, together with the legal entities with which they have professional and commercial relations linked to the shooting of event images, to acquire the right, free of charge, to use such images on any type of

visual support and/or promotional and/or advertising material for the maximum time required by the regulations in force.

Having read the Privacy Policy, the competitor acknowledges that the aforementioned processing is also strictly related to the purposes indicated in the Policy for which consent is not required, without prejudice to the rights set forth in the Articles 15 et seq. of the GDPR, which may be exercised at any time as better described in the Privacy Policy. Final Notices

The organizers guarantee the organization of an event in safety according to the rules and regulations in force at the time of the event. Any further specifications will be indicated if necessary. The organization will adopt all the regulations and protocols indicated by the government, the scientific technical committee and the Italian Athletics Federation.

The Organizers will do everything to reduce the risk of contagion: the best result will be achievable with the active collaboration of each participant.

The Organisers reserve the right to amend these regulations at any time for reasons they deem appropriate for better race organisation. Any changes to services, locations and times will be disclosed to registered athletes or will be reported on the www.runromethemarathon.com website. In addition, the documentation containing the essential information to take part in the competition will be delivered by the organisation together with the bib number.
