

Official Regulations – Saturday 5km

Infront Italy S.p.A. as a temporary grouping of companies together with Corriere dello Sport S.r.l., Atielle Roma S.r.l. and Italia Marathon Club, a limited liability amateur sports club, affiliated to the Italian Athletics Federation (FIDAL) with code RM094 (hereinafter jointly referred to as the "Organizers"), organize the non-competitive recreational run or walk, officially named "Saturday 5km", over a distance of about 5 Km, voluntarily and autonomously.

The Saturday 5km will be on Saturday 21 March 2026 at 9am. The start will be at Via dei Fori Imperiali and finish line will be at Circo Massimo. Please note that changes in place and time may be possible due to particular technical, organizational and health needs and/or provisions of the authorities

Rules of participation

The Saturday 5km is the non-competitive recreational city run in conjunction with Run Rome The Marathon. Participation is allowed at any age, but children under 14 must be always with a parent or a legal tutor. In order to participate, it is necessary to read and fully accept these rules.

Entry fees

The bibs of the Saturday 5km can be purchased through the official website of the event www.runromethemarathon.com at the following rates:

Individual Children (0-8 years old)

€ 5,00 – only bib and medal (no race pack, no T-shirt)

Individual Adults (over 8 years old)

€ 15,00 – bib + race pack (including Joma technical T-shirt) + medal

Groups of at least 4 people (over 8 years old)

€ 12,00 – from the fourth participants - bib + race pack (including Joma technical T-shirt) + medal

Early price Adults (over 8 years old)

€ 9,99 – until 1 September 2025 - bib + race pack (including Joma technical T-shirt) + medal

The participant will receive an e-mail communication valid as an official "confirmation letter". This e-mail will contain all the basic instructions for collecting the bib and participating in the Saturday 5km. It will not be necessary to print a hard copy of the email, it will be possible to present it on an electronic device such as a smartphone or tablet. The registration fee includes:

- Bib number;
- Gym bag with any products offered by sponsors;
- Official T-shirt in technical fabric; (not for children 0-8 years old)
- Participation medal

How to register

Registration must be done online, following the instructions on the website www.runromethemarathon.com. If the participant has purchased a code from a third party, it is to be used on the site to finalize the registration.

Closing of registration

The finalization/registration must in any case take place on the site of the event, in the appropriate section by 18/03/2026 for registrations with collection at the Expo village of the Run Rome The Marathon and by 01/03/2026 for registrations with home delivery.

Entries received after this deadline will not be accepted. The organization reserves the right to close registrations in advance or to accept registrations after the closing date at its sole discretion.

The deadline for payment by bank transfer is five days before the close of registration, after that date it will still be possible to use the other payment methods.

In any case during the days of the event registrations will only be accepted in person at the Expo Village and not online.

Bib numbers and event packs pick-up

The bib number and the race pack (gym bag with any products offered by sponsors and the official T-shirt) can be collected at the Expo Village of the Run Rome the Marathon (Palazzo dei Congressi, Piazza John Kennedy 1, Rome), on Thursday 19 and Friday 20 March from 9 am to 8 pm, upon presentation of a valid identity document, confirmation letter. The bib numbers can be collected from designated third parties after showing: the appropriate signed form of delegation, valid identification document, confirmation letter.

It will be possible to choose the home delivery option at a cost of:

- To Italy: € 7.00 per race pack (bib included) or € 4.00 per race packs for group registrations (single delivery address);
- To EU countries: € 20,00; €10.00 per package for group registration (single delivery address);

For those who choose the home delivery, the bib number and the race pack will be delivered starting from 7 March 2025. The delivery will take place by express courier within 24/72 working hours from the data of shipment.

Security procedures

Further information and more details will be provided to athletes in the weeks preceding the race with reference to the recommended sites to perform the activity.

Missed performance

If the race is cancelled, postponed to another date and/or, in any case, not held due to causes not dependent and/or not attributable to the will of the Organizers, including the revocation of the authorization to run by the competent Public Bodies, for any reason whatsoever, the participant will not be able to make a claim against Infront Italy S.p.A. or other co-organizers, not even as a reimbursement of expenses incurred and sustained. The signing of the application form is also valid as a waiver of any claim for damages and/or compensation, and/or any claim for compensation and/or the reimbursement of any financial loss suffered and being suffered.

Statement of liability

By registering for the "Saturday 5km", the participant declares that they are fully aware and unconditionally accept these rules and regulations and they are aware that participating in the "Saturday 5km" and/or sporting events in general is potentially a risk activity. The participant also declares that they assume all risks arising from their participation in the event: falls, contact with vehicles, other participants, spectators or others, weather conditions, traffic and road conditions, or any type of well-known and assessed risk. By submitting the online registration form, the participant absolves and indemnifies the Organizers, the promoters, the City Administration of Rome, the Regional Administration of Lazio, all Sponsors of the event, their respective representatives, successors, officers, directors, members, agents and employees of the above mentioned companies, from all present and future claims or liability of any kind, as well as for damages to persons and/or property, known or unknown, resulting from their participation in the event.

Furthermore, by submitting the online registration form, the participant declares that they are not aware of any previous medical condition or injuries that could put themselves at risk during the event.

Privacy and Image Rights

In relation to the processing of personal data, the competitor, by selecting the appropriate box at the bottom of the online registration form, declares to have read the information pursuant to Art. 13 of EU Regulation 679/2016 ("GDPR") ("Privacy Policy") made available through links and to have been informed through the aforementioned Privacy Policy that the consent for the processing of data strictly necessary to participate in the race is not necessary, insofar as the different legal bases of the processing indicated operate. The provision of personal data by the competitor is optional, however, refusal to provide data will make it impossible to proceed with the registration for the activity in question. For purposes not strictly related to participation in the race, the processing will only take place with prior consent, which, in any case, may be revoked by the competitor at any time.

The data must be complete, up-to-date and readable for insurance purposes.

The data, as better indicated in the Privacy Policy, which is an integral part of these Regulations and which is herein intended to be referred to in full, may also be disclosed and processed by third parties who offer services connected and related to the competition, such as, by way of example: services with the purpose of timekeeping, drawing up and announcing the results lists and services for the purpose

of photographing or filming the competitor. These entities, with regard to the processing carried out on behalf of the data controllers (as defined in the Privacy Policy) in relation to

activities outsourced by them, will act as "external data processors" pursuant to Article 28 of the GDPR. Some, however, may act as "data controllers" of the data transmitted, subject to the issue of appropriate information pursuant to Art. 14 of the GDPR, unless

otherwise provided by law.

The competition will be the subject of audio-visual filming and consequently images, photos, videos, audio - and/or video recordings of any kind in which the competitor may appear, as well as the results and rankings, may be the subject of disclosure, publication and/or dissemination in any form. Athletes expressly authorize the Organizers, together with the legal entities with which they have professional and commercial relations linked to the shooting of event images, to acquire the right, free of charge, to use such images on any type of visual support and/or promotional and/or advertising material for the maximum time required by the regulations in force.

Having read the Privacy Policy, the competitor acknowledges that the aforementioned processing is also strictly related to the purposes indicated in the Policy for which consent is not required, without prejudice to the rights set forth in the Articles 15 et seq. of the GDPR, which may be exercised at any time as better described in the Privacy Policy.

Final Notices

The organizers guarantee the organization of an event in safety according to the rules and regulations in force at the time of the event. Any further specifications will be indicated if necessary. The organization will adopt all the regulations and protocols indicated by the government, the scientific technical committee and the Italian Athletics Federation. The Organizers will do everything to reduce the risk of contagion: the best result will be achievable with the active collaboration of each participant. The Organizers reserve the right to amend these regulations at any time for reasons they deem appropriate for better race organization. Any changes to services, locations and times will be disclosed to registered athletes or will be reported on the www.runromethemarathon.com website. In addition, the documentation containing the essential information to take part in the competition will be delivered by the organization together with the bib number.
